It is the most consistent, universal human experience—an echo of divine order reverberating in the human soul.


Conscience is the compass of the spirit, orienting us toward true north, toward the character of God Himself.



Among the most significant investigations is The AWARE Study (AWAreness during REsuscitation), led by Dr. Sam Parnia at the University of Southampton and published in Resuscitation (2014). This multicenter clinical trial followed 2,060 cardiac-arrest patients across fifteen hospitals in the United Kingdom, the United States, and Austria. Of the 330 who survived, 140 reported conscious experiences despite having no measurable brain activity. One patient accurately described visual details of his resuscitation lasting more than three minutes after the loss of heartbeat—timed to a period of documented cerebral silence.

Further corroboration comes from neuro-intensivist Dr. Peter Fenwick and cardiologist Dr. Pim van Lommel, whose 2001 study in The Lancet tracked 344 cardiac-arrest survivors across ten Dutch hospitals. Eighteen percent reported veridical perception—seeing or hearing events later confirmed by medical staff. Statistical analysis showed no correlation between NDE occurrence and oxygen deprivation, medication, or fear of death, implying that the phenomenon could not be reduced to physiology alone.

He is not an abstraction of theology but a loving fatherly presence, immediate and tender.

He is my Eternal Father and yours. He is infinite in knowledge yet intimate in care.

I know that Jesus Christ is His Son—the living Word through whom all worlds were organized, who came to Earth, suffered, and rose again so that creation might be redeemed. His resurrection is not metaphor; it is the fulcrum of history, witnessed by eye and heart, reason and revelation.

The resurrection of Jesus Christ is not only a matter of faith but one of history. Even the most skeptical scholars acknowledge that Jesus of Nazareth lived, taught, was crucified under Pontius Pilate, and that His followers believed they saw Him alive again.

More than five hundred witnesses, as recorded by the Apostle Paul claimed to have seen the risen Christ (1 Corinthians 15:6), many of whom willingly suffered persecution and death rather than deny their testimony.

The tomb was empty; the body was never produced.

Enemies of the movement admitted the fact but could not explain it.

Within weeks, the once-terrified disciples boldly proclaimed His resurrection in Jerusalem itself—the very city where He was executed.

No other event in ancient history is attested by such a convergence of firsthand witnesses, documentary evidence, and enduring transformation.

The risen Christ stands as both the spiritual and historical cornerstone of faith and reason alike—a living proof that light conquered darkness, and life triumphed over death. Christ is my friend and mentor. I trust Him. I love Him and I worship Him.

I know, too, that ministering angels attend to the work of God on Earth—messengers of light who move unseen, inspiring, protecting, and fulfi lling His will among His children.

Sometime these angels are us. I remember a time when I had been admitted to the hospital in Utah with severe abdominal pain. Finally, after a full day of regerous tests I asked my father and a good friend to come to the hospital to give me a blessing. I was amazed that as my father spoke the words of the blessing, I was immediately and profoundly healed. The pain was instantly gone. I felt as if a large pail of warm spirit had been poured over my entire body and as it covered me I was transformed and made whole. I can never deny that powerful experience of healing at the hands of faithful men of God.

Faith is not the opposite of science; it is its completion. Science describes the how of creation; faith reveals the why. Reason can map the architecture of the universe, but only faith can explain the warmth in its light.

There is a sacred language that transcends logic—the language of the Spirit.

It does not contradict evidence; it expands it, reaching into realms the five senses cannot touch. It speaks in impressions, in clarity, in unmistakable peace. To those who listen, it confirms what the data already suggest: that the universe was not born of indifference but of intention, not from darkness but from divine love.

And with that knowledge comes responsibility.

God endowed His children with agency—the power to choose.

Choice is the engine of creation in miniature; every decision shapes reality toward light or shadow. The moral prime directive is clear: choose wisely, choose love, choose light.

Our judgments must weigh not only outcomes but the spirit behind them, for to choose truth is to align with the energy that sustains all worlds.

For the laws of physics declare His order, the patterns of life reveal His artistry, and the still, small voice confirms His love.
